Much like the Hippocratic Oath, the code of Dental Ethics created by the American Dental Association (ADA) serves as a standard to which all dental professionals are expected to adhere. It states that each member of the dental profession is responsible for "maintaining and enriching" the dental profession.

**Basic Ethics in Dentistry - Dental Learning**

The Hippocratic Oath requires that the health care provider promise to keep the sick from harm and injustice. The American Dental Association's (ADA) publication, Principles of Ethics and Code of Professional Conduct, states that "the principle expresses the concept that professionals have a duty to protect the patient from harm." Over time the definition of nonmaleficence has evolved to include preventing and removing harm.
